- Monitor the effectiveness of the contractors in the delivery of the projects and provide feedback to the Commercial and Estimation team in support of contract strategy development and report and escalate as needed;
- Provide strategic advice and support in relation to all aspects of the Project Management Plan;
- Provide review and endorsement of project variations above the financial DOA of the PM or where requested;
- Lead the delivery of a program of works by
  - o planning and designing the overall program of works and proactively monitoring its progress, resolving issues and initiating appropriate corrective action;
  - o allocating project resources;
  - o securing all necessary internal and external project approvals;
  - o managing the program's budget on a program level, monitoring expenditures and costs against the program baseline and provide up to date business plan and F(x) forecast;
  - o managing all interdependencies and interfaces between the program of works/discipline and
  - o implementation and maintenance of business processes, including governance, risk, financial management and reporting systems that enable effective delivery of projects in a timely and commercial manner;
- Derived the architectural framework for the relevant discipline (Substation, Line and Contracted) for successfully delivering multi packages projects (10++) over the five (5) year reset period;
- Provide strategy and guidance for highly acceleration projects to the relevant discipline, including and not limited to bespoke contract establishment, acceleration schedule, team structure etc;
- Detailed knowledge and ability to gain an in-depth understanding of emerging technologies in the relevant discipline;
- Subject matter expert and Delivery division representative for Safety in Design;
- Provide guidance and act as the lead assuror per ElectraNet business protocols and SPARQ methodology.
