Capable of working for extended periods under general supervision, as part of a small team contribution technical advice and operational support in:

### Proactively manage and coordinate outages by contributing to:

- Preliminary security assessments for transmission network outages and permission to proceed for distribution network outages impacting the transmission network.
- Ensuring information in ElectraNet and AEMO outage schedules is accurate and maintained in a timely manner.
- Preparing, checking and processing switching programs in accordance with current Switching Manual
- Providing support and specialist technical advice to Network Switching Writer (NSW) role, customers and other groups within ElectraNet.
